  - c. Received Community Action Grant of \$75,000 to install Heat Pumps at the City Buildings \$75,000, with no match required through the Community Resilience Partnership.
    - i. New round of this grant is open
    - ii. There are 96 resiliency action options to choose from
    - ii. Application is due August 29, KVCOG can assist with application
