CLARIFICATION:

SECTION 0700, Accessories 3.04 Lawn Hydrant – Hose Spigot

A. Install lawn hydrant per manufacturer's instructions and recommendations.

Additional information added for Lawn Hydrant service and City water main connection:

- B. Coordinate water connection and service with John Cameron, DPW and Zack Lovely, Superintendent, Gardiner Water District based on the following general information and Water District recommendations. Contractor to provide all labor and materials as outlined below:
 - 1. Tap in to existing 10" cast iron City water main located approximately 8' from edge of curb on Mechanic Street. Water main is approximately 6.5' deep. Assume temporary disruption to 2 on-street parking spaces. Maintain traffic flow on Mechanic Street.
 - 2. Tap to be 1" corp, direct tap.
 - 3. Install 1" diam. copper water line to meter pit (for bidding purposes, assume 25'at a minimum 5' deep).
 - 4. Install 1" Ball Curb Stop with Curb Box and Cover, located in Mechanic Street.
 - 5. Assume 1.5" diameter core through existing 15" thick concrete wall at park edge. Seal gaps around the installed pipe with hydraulic cement.
 - 6. Install mater pit on park side of service.
 - 7. Connect lawn hydrant to meter pit.
